TERMS and CONDITIONS

2. Authorized Site and Users

ASME grants to the Subscriber and Authorized Users at the Subscriber's Authorized Site (s) online access to the ASME Online Journals. This grant extends only to the Subscriber and such Authorized Users individually and may not be transferred to, or extended to, others. For purposes of this License, the "Authorized Site" is described in Appendix A. Remote campuses or remote sites not listed in this agreement are not allowed under this license.

The following are Authorized Users for purposes of this Agreement:

The Subscriber will exercise reasonable vigilance and shall be responsible for all access control and security measures necessary to ensure that the Subscriber's IP addresses are not used to access the online platform by other than Authorized Users. Appendix B. INSTITUTIONAL IP ADDRESSES/RANGES
